2. An invoice for storage services in a temporary storage warehouse, customs warehouse, public warehouse is issued at least once a month.

1 if the vehicle contains goods that have arrived at the address of several consignees, the cost of services is divided equally by the number of consignees

2 light vehicles - cars, motorcycles, mopeds, scooters, ATVs, motor boats, etc., similar in size

3 full / partial hour

4 when placing goods and vehicles in temporary customs control zones

5 other pallets, the overall dimensions of which are more than 1.2m x 0.8m x 1.65m

6 is charged for each type of work. Double rate applies for overtime work

7 the service involves the direct weighing of goods by an authorized person. In the case of attracting loaders, the service "Reloading, moving goods" is additionally paid
